

## FACT SHEET AND AUDITION PROCESS & RULES

**WHAT:** The Spring River's Got Talent 2022 event will showcase local musical talent competing for prizes.

**WHEN:** The event will be held on September 17, 2022. Doors open at 1pm and show will start at 2pm.

Snack food will available for purchase.

WHERE: Hardy Civic Center, 301 West Main Street in Hardy, AR. Parking limited, carpool encouraged.

**ORGANIZERS:** The Spring River Area Chamber of Commerce (SRACC) and the Arts Center of North Arkansas

(ACNA) are the organizers and promoters of the event. The 2022 SRGT proceeds will be used for ACNA's Cherokee Village location's operating costs to display and sell works by local artists and provide various art classes, such as painting, photography, music, jewelry making, sculpture, etc.

**TICKET PRICES:** \$15 for Adults, \$10 for Students, and age 5 and under are free.

**CATEGORIES:** There will be 2 categories for performers:

1) **YOUTH:** Age 14 and under: Only 5 performers will be chosen to compete for trophies and smaller money prizes in 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Places (amount to be determined based on ticket sales.)

2) **ADULT**: Age Over 14: 10 performers will be chosen to compete for one of 3 cash prizes: \$1000 for 1st Place, \$500 for 2nd Place, and \$250 for 3rd Place.

## **AUDITION PROCESS AND RULES:**

- 1) Performers must email an audition video or link to view performance of the song they plan to perform at the event no later than **August 31** to: <a href="mailto:info@sracc.org">info@sracc.org</a> and <a href="mailto:lauren@hallmarktimes.com">lauren@hallmarktimes.com</a>. It must be the song you plan to perform at event. (Performers selected will be notified by September 1st.)
- 2) Email must include the following information:
  - a. Contact name, phone, email, address
  - b. Type of performer: solo singer and/or instrumentalist, duo or band.
  - c. Performer's name if different from contact name (i.e. band name and member names)
  - d. Include written song lyrics ( All songs must be family friendly without directly or indirectly alluding to sex, drugs, alcohol, foul language or subjects that would be inappropriate for children. If deemed inappropriate, it could cause disqualification.)
- 3) Performance must be limited to 3 or 3 ½ minutes maximum.
- 4) If chosen to compete, you must have a second song chosen in case of a tie.
- 5) No song choices may be repeated by other competitors so songs will be approved on a first-come basis as they are submitted. If your song choice is not available, we will contact you to give you an option to choose another.
- 6) Non instrument performers must provide background music without other voices in a quality medium to be played during event.
- 7) Previous winners of this event may not participate, but will be welcome to attend as our guest and be recognized.
